The price quoted for “**On the Trail of the Mothergoddess,**” **\$2650** per person is based upon double occupancy in luxury or boutique hotels including a cave hotel, meals specified on the itinerary, guidance, airport transfers, all museum entrance fees, portorage at hotels, restaurant tips for included meals, taxes and transportation within Turkey during the tour. Single supplement is available at **\$490** and may be required if you are traveling alone and if there are no other single travelers you can be roomed with. Our itineraries provide a physically active daily program: climbing stairs, and walking on uneven and potentially slippery surfaces.

Reservations Space on the tour is limited. To reserve space, please fill out the booking form and e mail, fax, or post it to Mythic Travel. To guarantee your place, pay the deposit of \$500, by filling out the mail order form and by faxing it to **1-866- 888-1624**, or by mailing a check to **Mythic Travel** at **655 Bayview Dr. Aptos, CA 95003** or by using PayPal with the “**PAY NOW**” option on the **Mythic Travel website** home page <http://www.mythic-travel.com/>. Upon receiving your payment, Mythic Travel will e mail you a confirmation notice and mail you a letter with flight information and trip cancellation forms and medical insurance information.

Payment Schedule. At the time you make your reservation please send a deposit of **\$500**. The balance of **\$ 2150** payable to Mythic Travel, Inc. is due not later than **May 1, 2010**. Mythic Travel may accept late payments up to two weeks prior to departure on a space available basis subject to a \$300 assessment. If you enroll for this tour after **June 2, 2010**, you will be put on a space available basis and an additional charge of \$300 (total late fees of \$600) will be assessed to cover changes to hotel and land transportation guarantees as well as an additional fee for late airfare bookings to be determined by Turkish Air Lines if domestic flight arrangements are part of your tour.

Cancellation and Refunds. You can get a full refund of all payments (**minus \$75**) you have made up to **May 1, 2010**, if you cancel in writing, postmarked before **May 1, 2010**. No refunds will be made after **May 1, 2010**.

Insurance. Mythic Travel recommends that tour participants purchase insurance for trip cancellation, trip delay, and baggage loss. We require that tour participants purchase insurance for medical coverage.

These paragraphs together with the Release of Liability section of the Application Form define Mythic Travel's responsibility with respect to all of our tours. **PLEASE READ IT CAREFULLY.** Payment of your deposit represents your acceptance of the following terms and conditions:

Mythic Travel purchases all services including transportation, hotel accommodations, restaurants and other services from independent suppliers who are not affiliated with Mythic Travel in any way. Although Mythic Travel endeavors to choose the best suppliers available, we have no right to control their operations and therefore, Mythic Travel offers our tours upon the express conditions that Mythic Travel and its agents and employees shall not be liable for any delay, mishap, inconvenience, expense, bodily injury or death to person, or damage to property occasioned through the conduct or default of any company or individual providing these services.

Mythic Travel shall not be liable for: 1) expenses such as additional hotel nights and meals not specified in the individual tour itineraries that may be required en route, prior to, or following a tour, when caused by client's travel arrangements, by airline scheduling or airline schedule changes, canceled flights, missed flight connections or by other factors not under Mythic Travel's control; 2) expenses incurred in recovering luggage lost by airlines, belongings left behind on a tour, or in shipping purchases or other goods home from abroad; 3) personal expenses incurred by a client during the tour; 4) bodily injury or property damage, inconvenience, or expense caused by or resulting from occurrences, negligent or otherwise, due to the malfunction of transportation equipment, strikes, acts of God, war or civil strife, delays, fire, theft, or changes in government regulations

Reasonable changes in the itinerary may be made where deemed advisable for the comfort and well being of the tour members. Mythic Travel reserves the right to substitute hotels, alter the itinerary, and revise the order of places to be visited. Mythic Travel reserves the right to take photographic or film records of any of our tours and may use such records for promotional or commercial purposes.

Mythic Travel and/or its agents reserve the right to decline to accept any person judged to be incapable of meeting the requirements of participating in the activities of the tour or any person whose actions or deportment impede tour operations or the rights, welfare and enjoyment of other tour participants. A pro-rata refund based on cost of unused land services is the limit of Mythic Travel's responsibility in such a case. This constitutes full and final settlement.
